

**101:
STUDENT INFORMATION SHEET AND SCHEDULE
FOR FINANCIAL AID AWARDS**

STUDENT ELIGIBILITY REQUIREMENTS

Students applying for a 101: award must be graduating from Princeton High School, have acceptance at a college, technical school, or vocational school; and have a desire to further their education. They must meet financial eligibility requirements as determined by a financial aid expert. The financial eligibility will establish the monetary need for first year tuition that cannot be met by personal or family resources or by other scholarship awards. All scholarships from 101: are sent directly to the educational institution.

TIMETABLE FOR DETERMINING STUDENT ELIGIBILITY

<u>March</u>	101: Confidential Financial Statement and the Application Information Form may be picked up at the Princeton High School Guidance Office or downloaded from fund101.org. These forms must be filled out in order to apply for a 101: grant.
<u>April</u>	Financial Statement is forwarded to the Princeton University Financial Aid Office where it is assessed and financial eligibility is established.
<u>Early May</u>	Each applicant will be notified as to whether he/she is eligible for an award. Final eligibility will be determined after financial aid from other resources is known.

INTERVIEWS

101: – in late April, a 101: member will ask each student to talk about the school he/she has chosen, summer plans, and any additional financial resources for which the student has applied. The purpose of this information is to make sure the student has the information necessary to get all the financial help possible. If a student receives a full scholarship or is accepted for sufficient grants or loans to cover school costs, 101: may decide not to award a scholarship to that student.

In June, eligible students will be notified of the amount of the award from 101:.

PAYMENT SCHEDULE

For those students awarded scholarships, a check for the award amount will be sent to the school at the beginning of the fall semester.
